TERMS AND CONDITIONS

2. Materials to be used are as per specification and the same should be approved by the Engineer of the work.
3. Time of submission of quotation- Up to 3.30pm on 06-02-2020 and will be opened at 4pm at the same date.
4. Minimum time taken for work - 2 week from the date of work order.
5. The quoted rate should be inclusive of all taxes, duties, transportation, loading, unloading of all materials at site and all labour charges.
6. Payment will be made only after success full completion of the work and submission of bills by account payee cheque only.
7. The work should be completed as per Standard specification and the direction of Engineer.
8. No compensation for wastage or damage etc. caused by rain, snowfall, floods, any other natural cause whatsoever during the execution of work. The damage to work will be made good by the quotationer at his own cost and no claim on this account shall be entertained.
9. Similarly, if the quotationer /his workers cause any damage/loss to MCC property then it should be made good/repaired at his own cost. In case he fails to make good the damage/loss then the work will be got executed by MCC from some other agencies at the cost of the quotationer and the cost incurred for the same will be recovered from the bill.

The quotation should be an unconditional one and the quotationers are not permitted to impose any of their conditions, stipulations, alterations, commissions, and instructions, specify any terms for executing the work under this contract other than those specified herein.
