8. Application Fee:

The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of Rs.100/-(Rupees Hundred only) for SC/ST category and Rs.200/-(Rupees Two Hundred only) for others.

- **Only SC/ST caste categories listed in the Kerala PSC will be considered.** Applicants from other states belonging to SC/ST categories, not listed in the Kerala PSC will be considered as General category.

9. Candidates should produce the **original Certificates** along with a **self attested copy** of the same at the time of interview.
10. Communication of Interview/Test will be only through **e-mail/Website**. Candidates are advised to visit our website www.mcc.kerala.gov.in regularly for updates/notices and announcements.
11. Age will be calculated as on 1st January of the year i.e., **01.01.2025**.
12. The experience will be calculated from the date on which requisite qualification is obtained to the date of notification.

General Conditions
