GENERAL INSTRUCTIONS FOR WALK IN INTERVIEW

Interested and qualified candidates may report for the Walk in Interview with Bio-data, Original and copy of certificates to provide their age, qualification, experience etc. Details are as follows:

1. No of vacancies : Existing And Arising Vacancies
2. Tenure of Appointment : For contract staff posted in INSeR- MCC (PGIOSR) will be 365 days initially and can be extended for a maximum period of 3 years, subject to satisfactory performance(Maximum 3 tenures)..
3. Mode of selection : Written test/Interview
4. Nature of appointment : Temporary(purely on contract)
5. Venue : Administrative Block, MCC (PGIOSR)
6. Application Fee : **Rs.100/-(for all candidates)**
7. Selected candidate will Posted at Malabar Cancer Centre (Post Graduate Institute Of Oncology Science & Research) on contract basis.
8. Candidate will mark their attendance at **09.00 AM** on **14/01/2026** by paying **Rs.100/-** as application fees. Late comes will not entertained.

9. Candidates without **copies of originals showing age, qualification and experience** will not be considered eligible for further recruitment procedures.
10. Selection will be based on qualification and experience and performance in the interview. Claims in respect of Qualifications, Experience, etc. should be supported by Self Attested copies of relevant documents; Candidates **should produce the originals at the time of interview**.
11. If the number of applications are high then a written/online test will be conducted
12. No TA/DA will be paid for the Interview/Written test.
13. Canvassing in any form will lead to automatic disqualification. Candidates are advised to desist from such unholy practices.
14. Age will be calculated from the date on 1st January of the year, i.e. **01.01.2026**.
15. The Experience will be calculated from the date on which requisite qualification is obtained to date of notification.
16. The Director – MCC (PGIOSR) will hold the right to reject any application without any information.
17. Candidates if selected cannot have any claims for permanency.

General Conditions

- ❖ Decision whether to admit the candidate for the interview in case he or she fails to bring any required document rests entirely at the discretion of MCC (PGIOSR), depending on the importance of the document.
- ❖ Each candidate will be called separately for the interview and interviewed in detail. If required, written test/online test shall be conducted.
- ❖ Any attempt to disrupt or interfere with the proceeding or any misconduct towards assisting staff or interview board members will disqualify the candidate without further explanation.
- ❖ Interview shall include questions related to subject knowledge, attitude assessment, aptitude assessment, subject assessment, personality assessment etc and may include practical assessment depending on the post to which the candidate appears.
- ❖ If candidate fails to complete the process of interview, he/she will not be ranked.
- ❖ In case suitable candidates are not available, experience will be relaxed as per the discretion of Director, MCC (PGIOSR).

Important Note

- ❖ Request for change/correction in the application form shall not be entertained under any circumstances.
- ❖ In case if it is detected at any stage that a candidate does not fulfill the eligibility norms and/ or that he/she has furnished any incorrect/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after appointment, his/her service is liable to be terminated. The decision of MCC (PGIOSR) will be final in this regard.
