#### 8. Application Fee:

- **Contract:** The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of Rs.100/-(Rupees Hundred only) for SC/ST category and Rs.250/-(Rupees Two hundred and fifty only) for others.
- **Stipendiary Trainees**: The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of Rs.100/-(Rupees Hundred only) for SC/ST category and Rs.200/-(Rupees Two Hundred only) for others.
- Only SC/ST caste categories listed in the Kerala PSC will be considered. Applicants from other states belonging to SC/ST categories, not listed in the Kerala PSC will be considered as General category.
- **9**. Candidates should produce the **original Certificates** along with a **self attested copy** of the same at the time of interview.
- **10.** Communication of Interview/Test will be only through **e-mail/Website**. Candidates are advised to visit our website www.mcc.kerala.gov.in regularly for updates/notices and announcements.
- 11. Age will be calculated as on 1<sup>st</sup>January of the year i.e., 01.01.2025.
- **12.**The experience will be calculated from the date on which requisite qualification is obtained to the date of notification.
