Terms and Conditions:

1. The sealed quotation superscripted thereon the name of work mentioned above and addressed to the Director, Malabar Cancer Centre, Thalassery
2. Materials to be used are as per specification and the same should be approved by the Engineer-in charge of the work.
3. Date & time of submission of dully filled quotation- **Up to 5pm on 07/04/2025**
4. Completion time of works - 2 week from the receipt of work order.
5. The payment shall be made only as per site measurement of works actually done.
6. The quoted rate should be inclusive of all taxes, duties, transportation, loading, unloading of all materials at site and all labour charges except GST.
7. Quoted amount should be exclusive of GST, GST @18% shall be paid extra along with bill.
8. Site should be visited before participating in the quotation process.
9. The approved quotationer should submit the copy of PAN card & GST registration certificate before submission of the work bill.
10. Payment will be released only after successful completion of the work and submission of bills through online bank transfer/RTGS
11. No compensation for wastage or damage etc. caused by rain, snowfall, floods, any other natural cause whatsoever during the execution of work. The damage to work will be made good by the quotationer at his own cost and no claim on this account shall be entertained.
12. The quotation should be an unconditional one and the quotationers are not permitted to impose any of their conditions, stipulations, alterations, commissions, and instructions, specify any terms for executing the work under this contract other than those specified herein. A conditional Quotation is liable to be summarily rejected.

13. If any damage or loss occurs to MCC property while executing the work, the same shall be made good after making necessary repair/replacement works at contractor's own expense. In case the Contractor fails to do so the damage/loss/work will be got executed by MCC by other agencies at the risk and cost of the Contractor. The expense thus incurred will be recovered from the contractor by any means MCC may deem to fit.
14. The agency should take all safety precautions to avoid accidents during execution and also responsible for all damages and accidents caused due to negligence.
15. No hindrance shall be caused for the normal working of the hospital during the execution of above work.
16. The agency will have to comply with the security restrictions enforced by Malabar Cancer Centre. The directions issued by MCC should be strictly followed by the labourers so as to ensure minimum disturbance to the hospital functioning.
17. The under signed has reserves the right to reject any or all the quotations or postpone the bid without assigning any reason.
