2. Late comers will not be entertained.
3. An application fee of Rs. 100/- to be paid for all candidates.
4. Duration of Contract Staff posted in Malabar Cancer Centre will be 365 days initially and can be extended for a maximum period of 3 years, subject to satisfactory performance (Maximum 3 tenures).
5. Candidates without providing copy of certificates, proving age, qualification and experience, will not be allowed for attending the Interview.
6. Selection will be based on qualification, experience and performance in the Interview.

8. Candidates should produce the originals at the time of Interview.
